- ④ Earned income from 2 or more workplaces.
- ⑤ Paid more than 100,000 yen for medical expenses as a household.
- ⑥ Household that spent over 12,000 yen for over-the-counter medicines.
- ⑦ A valid member of National Health Insurance, Social Insurance or Life Insurance, but monthly deductions are not being made.

### DEPENDENTS OVERSEAS

- Birth Certificate or Marriage Certificate.  
(original + Japanese translation + copy)
- Bank transfer statement (each dependent)

### MEDICAL EXPENSES

- Medical receipts ( ¥100,000 and above )
- Receipt of over-the-counter medicines ( ¥12,000 and above )  
+Medical examination certificate.

### MEDICAL INSURANCE, LIFE INSURANCE

- Receipt of monthly payments of your National Health Insurance, Social Insurance or Life Insurance.

### HOUSING LOAN DEDUCTION

- Calculation statement of special deductions for housing loan etc. and certificate of year-end balance of the housing loan.
