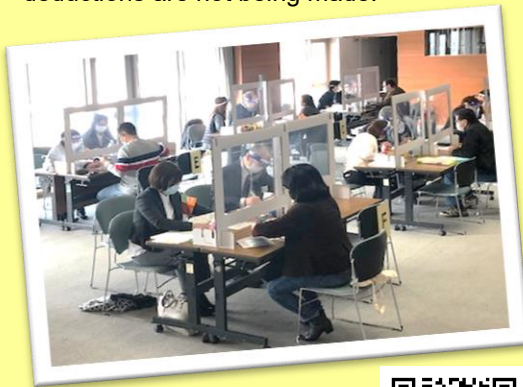

Declarations that will not be accepted: 1. Declaration of self-employment 2. Declaration of first house loan deduction

- ① People who did not receive a year-end tax adjustment in 2022.
- ② People who have changed, quit or lost jobs last year.
- ③ People who did not apply for dependents. (including the foreign remittances to support their family.)
- ④ People who have earned income from 2 or more workplaces.
- ⑤ People who have paid more than certain amount for medical expenses as a household (100,000yen or more in principle).
- ⑥ People who have spent over ¥12,000 for over-the-counter medicines as a household.
- ⑦ People who are enrolled in National Health Insurance or Life Insurance, but deductions are not being made.
