Foreigners must have a Status of Residence that permits working to be eligible to work in Japan. Please confirm that you are qualified to work in Japan.

## (3) Workmen's Accident Compensation Insurance (ROUSAI HOKEN)

This insurance covers expenses to compensate a worker (or bereaved family if the worker passed away) for damage due to injury or disease during work or commutation.

#### Premium

The insurance premium is paid by the employer.

#### **Benefits**

- Medical treatments
- · Absence from work due to damage for 4 days or more.
- · Compensation for any irrecoverable functional impediment or disability.
- · Compensation for bereaved family if the worker passed away.
- Funeral expenses of the worker who passed away.

#### Claim

When claiming the treatment, the worker should submit a proven document of the employer and insurance claim form to a hospital designated by the Workmen's Accident Compensation Insurance. For other claims, the worker should submit a proven document of the employer, medical certificate obtained from the doctor, and insurance claim form to the nearest Labor Standards Inspection Office.

## (4) Unemployment Insurance (KOYOU HOKEN)

This public insurance provides benefits to support unemployed persons to encourage the process of finding another job.

### Premium

Both employer and employee bear the responsibility of insurance premium payments at a fixed rate. For the employee's responsibility, the employer deducts the insurance premium from the employee's monthly salary.

#### Coverage

Insured workers who quit their jobs, but have the will and ability to work any time, and have not yet found a job despite actively searching for one, may receive unemployment benefits and other basic allowances. To receive benefits, workers must obtain confirmation of qualifications based on the conditions before leaving a job.

#### Claim

Submit applications to the nearest Public Employment Security Office (see p.33).
